INTRODUCTION PARAGRAPH:

- 1) Hook: "snag" your reader's attention with...
- Contextualize: set up some context for your topic/argument (2-3 sentences)
- 3) Thesis/claim/argument: place this at the end of your intro so that your reader knows the plan.

BODY PARAGRAPH STRUCTURE:

- 1) Topic sentence
- 2) Introduce evidence #1
- 3) Evidence (quote, etc.)
- 4) Analysis of evidence: How does this link to your topic sentence and main claim?

- 5) Introduce evidence #2
- 6) Evidence
- 7) Analysis of evidence #2
- 8) Transition to next paragraph.
